Vendor Application

Rules & Regulations for The Market

Business name:

All poultry for sale must be tested by the state and must present certification paperwork at the start of every event

Individual Name:

Food sale allowed if you have all state required certifications and licenses to sell in MA. Food vendors must make and package all food items off-site. No food prep will be allowed at The Market

Contact Info:

Only products certified by a USDA National Organic Program accredited certifying agent that certifies farm operations and processors may be labeled "Organic"

Physical Address:

No sales of alcohol or tobacco
No petitions
No political or religious solicitation
No medical, promise of cure or advocating for anything medical – no care providers, massage therapists, acupuncturists, chiropractors or products taken orally promising to relieve a medical condition

Produce/Products:

Vendors are required to comply with all federal state and/or local laws and regulations

Space Requirement:

Vendors are responsible for insurance to cover the extent of their operation and liabilities – the site provides general 'trip/fall' coverage for the grounds only

Insurance Documents- please provide copy if necessary

All necessary permits, licenses, insurance are the vendors' responsibility

BOH Documents- please provide copy if necessary

Anyone selling baked goods or processed goods must have a "permit to operate a food establishment" issued from their towns board of health, as defined in the sanitary code, and have a copy in their possession during the market

Any vendor weighing produce/product must get their scale inspected by an official city or state sealer of weights and measures.

All prices must be posted clearly

Vendors may initiate setup 1/2 an hour prior to event start time. Vendors must vacate the selling area no later than 1/2 hour past event end. All selling area must be cleaned and restored to the original appearance

Vendors must grow/produce at least 75% of what they sell and must be from within a 50 mile radius of Townsend

Name of farm and town of origin of the product being resold is to be clearly posted

Any violation shall subject violator to permanent removal from The Market

The site will provide a restroom and potable water only, all other necessities are the vendors responsibility

Vendors must provide an approved trash receptacle when selling ready to eat items

Vendors must be courteous to other vendors and to the public at all times
