"Bliz Whiz" Sno-Cone Machine Operational & Safety Instructions ...

Like anything else in our store, each and every piece of equipment is potentially dangerous. The same applies to our full line of "professional" concession equipment... blooming onion cutters, cotton candy, funnel cake fryers, hot dog rotisserie cookers, nacho & cheese servers, popcorn machines. Hawaii shaved ice machines and frozen slush / daiguiri machines. etc.! With that in mind, please take a few moments to go over the information printed below (both recommendations by the manufacturer and our own staff) to help lessen the chances of accident or injury! If you should have any questions. please call TRC immediately, never any equipment in doubt!

A. SAFETY PRECAUTIONS:

This equipment is commercial grade and is manufactured for high demand use. When in use for public food service locations, family events, etc., remember ...

- 1. Never allow direct contact of this equipment by the public keep all bystanders out of the work area.
- 2. Always follow any / all applicable rules and regulations (federal, state and local) as it pertains to food distribution (handling and safety). Only personnel trained in the use of this equipment may safely operate it.

Taylor Rental Center keeps the manufacturer's operational and instruction manual on file and it is available on request. Take adequate precautions so that no one can use this machine when the operator(s) of the equipment have left! Do not use this unit unless you have read these instructions and fully comprehend this material.

B. WARNINGS:

Always wear safety glasses when using. Never put fingers or any objects into the shaver body period (the gooseneck). Especially any objects while the motor is running or is plugged into an electric receptacle. In fact we would prefer that you never place anything into the shaver body / chute except ice! Serious injury may occur if this happens! Do not use this machine for anything other than what the manufacturer's intended use! NEVER make alterations or modifications to this equipment - doing so can create dangerous situations!

The "Bliz Whiz Sno-Cone Machine" uses 120-volts, 5.5-amps. It must be properly grounded ... plug directly into a 3prong, 120-volt electrical wall receptacle or you can add (up to 100' maximum length) 12/3-gauge "outdoor rated" extension cord to help prevent possible electrical shock to the operator! Do not allow the power cord, extension cord or power outlet to become wet! Do not use wet hands to plug ice shaver to an electrical receptacle! Do not immerse unit in water. Place the machine on the flat drain pan, make sure the white drain hose is open so that it may be hooked up to an additional drain hose or basin tub. Drain water should be directed away from the work area, so that the operator is not working in dampen area or standing water. Drain water from hose is not intended for human consumption! Be sure unit is on a table that is sturdy (see weight & dimensions below) and can withstand accidental dripping of water and ice.

D. OPERATING INSTRUCTIONS:

At the base of the machine are switches marked MOTOR and LIGHT.

TO LIGHT THE MACHINE;

Flip the switch marked light. You should leave the light on during your operating time. Return the switch to the off position to turn light off.

TO SHAVE ICE:

Flip the switch marked Motor. You may begin to place ice into the hopper. When you are finished shaving, return switch to the "OFF" position.

CAUTION; Do not allow direct contact of this equipment by the public or any other individuals when used in food service locations. Only personnel trained and experienced in the equipment operation may operate this equipment. Carefully read all installation instructions before operating this equipment. Secure this machine when not in use.

Make sure the electrical plug and or extension cord are plugged into a grounded receptacle.

ICE REQUIREMENTS; This machine can take bagged ice, ice cubes or block ice, provided you break the block ice into pieces approximately 3 to 4-inches in size. The ice will not enter the shaving chute if the pieces are too large. The design of the shaving chute automatically draws the ice against the blades. There is no need for manual effort.

OPERATING HINTS; You can shave a lot of ice in a short time (up to 500 lbs. per hour) but don't let the ice pile up and block the discharge chute. This will jam the machine. If this situation were to happen, use the following steps ...

- 1. Turn the motor switch to the "OFF" position and unplug the machine.
- 2. Clear the piece of ice out of the machine with a piece of wood.
- 3. Allow the remainder of the ice in the machine to melt.
- 4. The machine should be ready for use plug the machine back up and turn the motor on.

Never allow any foreign or metallic objects around the shaver area of this machine. Blades are often damaged by ice picks, scoops or debris that may be in the ice.

E. CUSTOMER RESPONSIBILITIES:

The Customer is responsible for the safe implementation and use of this equipment! When using outdoors ... avoid and / or discontinue use when weather conditions dictate; rain, mist, lighting, thunder, etc.! Unplug machine and remove from these weather conditions. Secure and use care when loading and transporting (unit weight - approximately 80 lbs., machine dimensions are 22" width x 16" depth x 29" height with lid open). Never expose to open weather when loading or transporting. Do not use this equipment if the you (the operator) or any operators are impaired! Do not use or modify this equipment in any applications. Do not use this machine for applications which the manufacturer has not designed nor intended its use! Visually inspect unit prior to use, never operate damaged or malfunctioning equipment, stop and call TRC immediately! We also ask that the customer be responsible for safe keeping / care of the unit (s) during their possession ... until the unit is returned to our store location (by the customer) or is picked-up by TRC's uniformed service personnel!

CAUTION; If you have arranged to pick-up the sno-cone machine at our location, it is your responsibility to make sure the machine is secure before driving off. Make the necessary adjustments for securing the machine to compensate as to how and where you drive.

Deliveries and Pick-Ups are priced separate and best scheduled prior to event! Call for pricing, if needed! Common sense, caution, proper training and familiarity with this equipment is the best means of avoiding injury to the operator and / or damage to the machine!
